Terms & Conditions of Sale

PAYMENT & TERMS: All OVA open accounts not paid within 30 days are considered past due, and a charge of 1.5% per month or 18% per annum will be assessed and added to the past due balance. All shipments to a past due account will be sent C.O.D. or may be delayed or refused. Farm Plan Accounts are also available, and payments not received within 30 days are past due and subject to the specifications of said account.

RETURN POLICY: 30 day return policy with a restocking fee on any return unless OVA was at fault and a RMA must be on package. No returns on open electronics. If returns are necessary for any reason, we ask that the customer please inform us of the reason for return. Return items via UPS or insured USPS. Please contact us if item is too large and requires freight line transport, and we will work with the customer to facilitate such transfers. All returned items should be insured for the customer's protection. Used merchandise may be repaired and returned at the manufacturer's discretion, as opposed to being replaced or credited.

DAMAGED/MISSING MATERIAL: In the event of receiving a damaged package or missing product you must contact us within five days after delivery. Failure to contact us within five business days may disqualify any warranties, replacements, and/or repairs.

WARRANTIES: All warranties are subject to the warranty of the original manufacturer. Warranty claims will be processed by Ohio Valley Ag after the items are returned freight prepaid to Ohio Valley Ag. **Freight is not covered under warranty to and from vendor.** Examination and determination of warranty, if applicable, will be subject to and limited by the warranty of the original manufacturer. Ohio Valley Ag assumes no liability for any unwarranted equipment. We encourage that all items are returned as soon as issues arise to help meet strict warranty time frames.
